Installation Requirements

- For indoor applications, use Category 5 (or above) UTP cabling approved for indoor use.
- For outdoor applications, shielded Category 5 (or above) cabling should be used for all wired Ethernet connections and should be grounded through the AC ground of the power supply.

We recommend that you protect your networks from harmful outdoor environments and destructive ESD events with industrial-grade, shielded Ethernet cable from Ubiquiti Networks. For more details, visit:

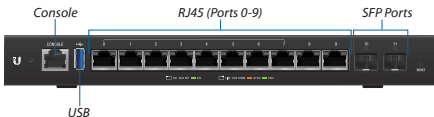

Console	<p>RJ45 serial console port for Command Line Interface (CLI) management. Use an RJ45-to-DB9, serial console cable, also known as a rollover cable, to connect the <i>Console</i> port to your computer. (If your computer does not have a DB9 port, then you will also need a DB9 adapter.) Then configure the following settings as needed:</p> <ul style="list-style-type: none">• <i>Baud rate</i> 115200• <i>Data bits</i> 8• <i>Parity</i> NONE• <i>Stop bits</i> 1• <i>Flow control</i> NONE

SFP Ports (Ports 10 - 11)	SFP routing ports are hot-swappable and support Gigabit fiber SFP modules.

Button	Description
Reset	<p>There are two methods to reset the EdgeRouter to factory defaults:</p> <ul style="list-style-type: none">• <i>Runtime reset (recommended)</i> The EdgeRouter should be running after bootup is complete. Press and hold the Reset button for about 10 seconds until the LED for port <i>eth9</i> starts flashing and then becomes solidly lit. After a few seconds, the LED will turn off, and the EdgeRouter will automatically reboot.• <i>Power-on reset</i> Disconnect the <i>Power Cord</i> from the <i>Power Adapter</i>. Press and hold the Reset button while connecting the power (refer to <u>“Connecting Power”</u> for details). The port LEDs will light up in sequential order. Keep holding the Reset button until the <i>System LED</i> starts flashing blue and white, and then release the button.

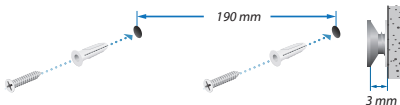
Hardware Installation

Wall Mounting

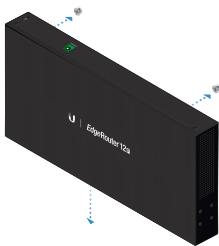
To mount the EdgeRouter on a wall, you will need a drill, a 6 mm drill bit, and a Phillips screwdriver.

1. Use a 6 mm drill bit to drill two holes 190 mm apart.
2. Insert the *Wall Mount Anchors* into the holes. Use a Phillips screwdriver to secure a *Wall Mount Screw* to each anchor. Leave a clearance of approximately 3 mm between each screw head and its anchor.



 **Note:** You can also mount the EdgeRouter in a vertical orientation.

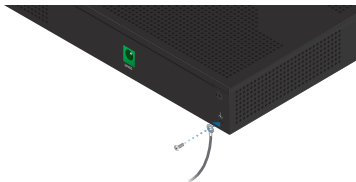
3. Position the EdgeRouter with the Ethernet ports facing down. Place the wall-mount slots of the EdgeRouter over the screw heads on the wall. Then slide the EdgeRouter down to lock it into place.



Grounding the EdgeRouter (Recommended)

The EdgeRouter is grounded through the *Power Adapter*; however, you can add optional ESD grounding for enhanced ESD protection.

1. Attach the *Ground Screw* to secure a ground wire (not included) to the *Grounding Point*.



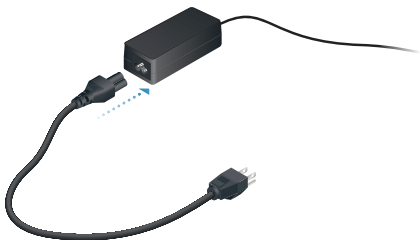
2. Optional: To secure the *Power Adapter* cord, insert it into the *Cable Clip* and secure the *Cable Clip* using the *Ground Screw*.
3. Secure the other end of the ground wire to a grounding block.

Connecting Power

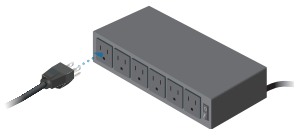
1. Connect the *Power Adapter* to the *Power* port.



2. Connect the *Power Cord* to the *Power Adapter*.



3. Connect the other end of the *Power Cord* to a power outlet.



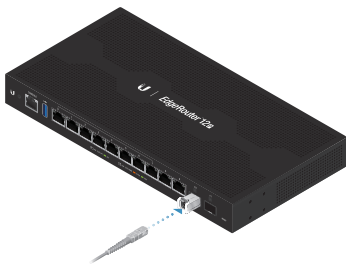
Using SFP Ports

To use an *SFP* port:

1. Remove the protective plug covering the *SFP* port.
2. Plug a fiber SFP module into the *SFP* port.



3. Connect a fiber optic cable to the fiber SFP module. Then connect the other end of the cable to another fiber device.

Accessing the EdgeOS Configuration Interface

The EdgeOS® configuration interface can be accessed via DHCP or static IP address assignment. By default, *eth1* is set up as a DHCP client, while *eth0* is assigned a static IP address of 192.168.1.1. To configure the EdgeRouter, proceed to the appropriate section: DHCP or **“Static IP Address”**.

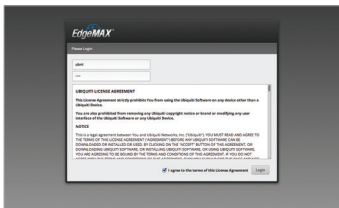
DHCP

1. Connect an Ethernet cable from *eth1* on the EdgeRouter to a LAN segment that has an existing DHCP server.



2. To check the IP address of the EdgeRouter, use one of the following methods:
 - Set up the DHCP server to provide a specific IP address to the EdgeRouter based on its MAC address (on the label).
 - Let the EdgeRouter obtain an IP address and then check the DHCP server to see which IP address was assigned.
3. Launch your web browser. Enter the appropriate IP address in the address field. Press **enter** (PC) or **return** (Mac).

- The login screen will appear. Enter **ubnt** in the *Username* and *Password* fields. Read the Ubiquiti License Agreement, and check the box next to *I agree to the terms of this License Agreement* to accept it. Click **Login**.

Static IP Address

- Connect an Ethernet cable from the Ethernet port on your computer to the port labeled *eth0* on the EdgeRouter.



2. Configure the Ethernet adapter on your host system with a static IP address on the 192.168.1.x subnet.
3. Launch your web browser. Type **https://192.168.1.1** in the address field. Press **enter** (PC) or **return** (Mac).
4. The login screen will appear. Enter **ubnt** in the *Username* and *Password* fields. Read the Ubiquiti License Agreement, and check the box next to *I agree to the terms of this License Agreement* to accept it. Click **Login**.

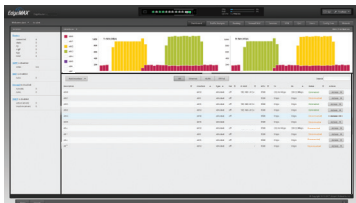

Configuring PoE Settings

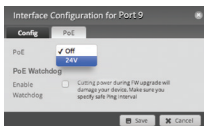
The PoE setting for ports 0 - 9 is set to **Off** by default.

! WARNING: Before activating PoE, ensure that the connected device supports 24V passive PoE and the supplied voltage.

1. In the *Dashboard* tab, click **Actions** > **PoE** of the Ethernet port you want to configure.



2. The *Interface Configuration* window will appear. Select the appropriate PoE setting, and click **Save**.



3. The Ethernet port's *PoE* LED will confirm the PoE setting.
